Our continued focus on special needs saw the sixth successful staging of our Digicel 5K Run with over 10,000 participants coming out to give their support and the completion of our promise to provide ten schools for special needs children with the opening of the Lyssons Centre of Excellence in St. Thomas. Now, more than 600 children with special needs have access to educational interventions to enhance their growth and development. The centres also provide training for parents to empower them to continue working with their children at home, using the same developmental exercises.

I would like to thank Jean Lowrie-Chin, our Chairwoman, and every single member of the Foundation team, our partners and all our staff volunteers for their phenomenal work. Run entirely by Digicel employees, our Foundation is at the heart of all we do. We are inspired each and every day by the people we serve. That is what drives us to do our best so that we can continue to work towards a world in which no one gets left behind.

It was a joy to welcome the brilliant Josefa Gauthier, Chairman of Digicel Haiti Foundation, for a tour of our projects. She was graciously received by Her Excellency Lady Allen at King's House. We have enjoyed strong leadership from former CEO Dane Richardson and CEO Karlene Dawson, and excellent support from our Board and staff members.

Because of their dedication, we were able to exceed our target for the Ramps in Schools initiative. We planned an exciting awareness-raising tour for Mary Davis, CEO of Special Olympics International, and celebrated the 40th Anniversary of our major partner, Special Olympics Jamaica.

The Digicel Foundation is grateful to the Digicel Jamaica staff for their spirit of volunteerism. Together, we have found that our greatest inspiration comes from our partners, especially those humble Jamaicans who use the support we offer to guide, educate and employ their fellow Jamaicans on a path of sustainability. # ceo's message



Fourteen years ago, the Digicel Foundation, under the patronage of Denis O'Brien, set out to make a difference in the lives of all Jamaicans. Through the dedication and hard work of every single member of the team, our project partners and beneficiaries, we have been able to do just that, through our three pillars of work.

We worked with the Ministry of Education as we strive to help create Jamaica's next generation of scientists and engineers. The team recently renovated science labs in four high schools in Eastern and Western Jamaica. This upgrade is geared toward helping students from grades 7 to 9 improve their performance in the science, technology, engineering and mathematics (STEM) areas.

Our commitment to the development of social enterprise work continued with our partnership with Comic Relief and the Queen's Young Leaders Programme. So far we have awarded 17 resourceful social enterprises with funding grants and training, offering opportunities for development and entrepreneurship anchored in social value.

We continue to promote and strive for the acceptance and inclusion of Jamaica's most vulnerable; furthering and encouraging their independence as they work toward sustainable futures shaped by community bonds. Our continued investment in organisations such as Special Olympics Jamaica, Deaf Can! Coffee and our work to renovate special

education units in schools across the island is evidence of our commitment to this area. Our key awareness campaign is the annual Digicel 5K Run for Special Needs. Six years in, it now attracts over 10,000 people. We also completed our tenth Centre of Excellence in Lyssons, St. Thomas, fulfilling a promise made by our patron Denis O'Brien to offer children with special needs access to educational interventions and the attention they need to aid in their development.

We look forward to even more growth as we deepen our partnerships, working with and serving our fellow Jamaicans as we move towards becoming a more developed society. We will continue to set the pace for others to follow, grateful for our partners, stakeholders and beneficiaries who help to make our work so rewarding.





Our work with various partners to build special spaces has seen the students thrive.


















### watering her roots...

### 1. Identification and Principal Activities

The company is a not-for-profit organisation which was incorporated in Jamaica on 30 September 2004. The company is limited by guarantee, not having a share capital. The registered office of the company is located at 14 Ocean Boulevard, Kingston. The principal activity of the company comprises the distribution and utilisation of funds on a charitable basis for the purpose of building and developing communities across Jamaica and the region.

The company is mainly funded by Digicel (Jamaica) Limited, incorporated in Jamaica.

### 2. Summary of Significant Accounting Policies

#### Basis of preparation

The summary financial statements have been extracted from the full financial statements, and prepared in accordance with Practice Statement 2016-01 issued by the Institute of Chartered Accountants of Jamaica. The full financial statements as at and for the year ended 31 March 2018 were authorised for issue by the Board of Directors on 16 October 2018. Those financial statements have been prepared in accordance with IFRS, and contain an explicit and unreserved statement of compliance with IFRS.

The summary financial statements do not include all the disclosures provided in the full financial statements and cannot be expected to provide as complete an understanding as provided by the full financial statements. The full financial statements are available at the company's office.

The full financial statements have been audited by PricewaterhouseCoopers who, in their report dated 16 October 2018, expressed an unmodified opinion in relation to those full financial statements.
